ELIGIBILITY: Original artwork only, completed within the last two years, and not previously shown in Kern County, CA. Nicole Browning reserves the right to refuse works judged unsuitable or with unusual requests. All artwork must reflect fashion and/or the world of fashion.

AWARDS: A Guest Judge will select the work for the exhibition from submissions and will determine the award winner, with a cash prize of \$100.

ENTRY APPLICATION: All artists must complete entry form with all information requested. A non-refundable fee of \$10, with only one entry per artist, is payable to Nicole Browning. Submissions will not be returned without a SASE.

ARTWORK IMAGE: Entry may be submitted in digital or photographic format, as per the following guidelines: Artwork can be submitted as an email attachment in .jpg format (300 dpi minimum), by CD, or an actual photograph. Be sure to indicate the title of the piece, medium, dimensions, and year completed.

DELIVERY OF WORK: All submissions are due to the Micro Gallery (6300 Coffee Road, Bakersfield, CA 93308) by June 1, 2010 by 6pm. To deliver submissions to the gallery before June 1, please make an appointment. After notification that work has been accepted, it must be hand-delivered or shipped to the gallery no later than June 12. All shipped work must arrive prepaid. Return shipping and shipping insurance is the responsibility of the artist.

SALES: All works submitted must be for sale. Commission is 30%, with 70% of the sale going directly to the artist. Artist will receive payment for work sold within one month after the close of the exhibition. The sale prices must be reasonable and in line with the artist's previous sales. For assistance with pricing, please contact Nicole Browning.

PREPARATION OF WORK: All work should be ready for installation with the proper hanging devices attached and special instructions included. Two-dimensional work must be gallery-wrapped or framed, must not exceed 60" and is the responsibility of the artist. Sculpture, including base, should not exceed 72" or 120 lbs.

LIABILITY: Nicole Browning is only responsible for the art while in the Micro Gallery. Work is covered for the percentage due to the artist upon sale. Nicole Browning does not accept responsibility for loss or damage during transit. Submission of the entry form serves as an agreement to the conditions of this prospectus.

ARTWORK PICK-UP: Please pick up work or arrange pre-paid shipping by Aug. 6. Work that remains at the gallery beyond Aug. 6 could be subject to a storage fee.
